# There are multiple ways of supporting church planting.

## Cash Gifts

Baptist Church Planters has two programs to encourage regular giving, Planters 500 (minimum \$5 a month gift) and the President's Circle (minimum of \$500 a year). Many others have participated in a one-time gift and it always seems to come in at a crucial time. One-time gifts are extremely helpful.

## Gifts of Property or Goods

Not everyone has cash on hand to give, but may very well have personal property that Baptist Church Planters can turn into cash. You can claim the market value of the given property as a donation on your tax return. Cars, campers, motor homes, silver sets, valuable jewelry, antiques, land, and houses are some of the possibilities.



## Foundation Gifts

With a minimum investment of \$25,000 you can receive an income for life. Interest rates depend upon your age at the time of investment. Baptist Church Planters receives an initial gift at the time of purchase and the remainder of the funds at the time of your death. ## Life Insurance
